## How Law Enforcement Management System works



The eGov Law Enforcement Management System adds new complaints to build new case investigation data by registering the issue in the system. Upon filing a case, an officer is assigned to investigate the case and record leads. Authorized officers can see the updates on progression of the case and determine how effectively it is being handled. Once the assigned officer arrests the suspect or defendant, the officer does a biometric search. If suspect or defendant's record exists in the system, the officer can then update the criminal record for that suspect or defendant. If there is no existing record, then the officer can create a new record and update all further information there. All added records are automatically logged for future transparency audits.

### Complaint Management
